## MEMBERSHIP CRITERIA

### ACTIVE Member: Annual Dues \$50.00

- Was not discharged for reason discreditable conduct
- Has had and still possess an exemplary character Association.

### **Regular Member (RM) & Civilian Member (CM)**

- a former member of the RCMP who was sworn in as a member of the force and who has served a minimum of one (1) day

### **Auxiliary Member and Reserve Member**

- a uniformed RCMP volunteer who was duly sworn into the Force and served not less than three (3) years as an Auxiliary or Reserve constable

### ASSOCIATE: [ No Annual Dues ]

- **Former Public Service Employee & Term Contract Employee**
  - a former RCMP Public Service Employee or former RCMP Term Contract Employee with a minimum of three (3) years' service
- **Spouses/Partners**
  - a spouse/partner of an Association Active or Life member
  - a spouse/partner of a Non-Association former or deceased member
  - a spouse/partner of a deceased serving member
  - Not eligible to hold elected executive office or director of a standing committee
  - Has voting privileges only on matters within the Division
- **Serving: Regular Member / Civilian Member / Public Service Employee**
  - a Serving Regular or Civilian member who has received the Good Conduct/Long Service medal or award, and a Public Service Employee who has twenty (20) years in the Public Service with the most recent three (3) years in the employment of the RCMP
  - Does not pay annual dues; does not have voting privileges; not eligible to hold executive office

### HONORARY: [No Dues]

- an Active or Life member in good standing may nominate a person for Honorary membership who has given considerable assistance and support to the RCMP and/or the RCMP Veterans' Association
